- 1) **Datum objave poziva:** 20.07.2011.
- 2) **Rok za prijavu projekata:** 23.11.2011. godine, do 17,00 sati po Briselskom vremenu.
- 3) **Evaluacija:** kraj evaluacije prijedloga predviđen za januar/februar 2012. godine.
- 4) **Ukupni budžet poziva:** 241,7 miliona evra.
 - Indikativni budžet od 45% (varijacije moguće od 35% do 50%) za teme koje će se implementirati kroz Intergracione projekte (IP) i Demonstracione projekte.
 - Indikativni budžet od 55% (varijacije moguće od 45% do 65%) za ostale teme.
- 5) **Napomena:** projektni prijedlozi ne smiju sadržavati bilo kakve povjerljive informacije!
- 6) **Konzorcijum:** zavisno od tipa finansijske šeme (CP, NoE, CSA); opšte pravilo: 3 nezavisne institucije iz 3 različite zemlje članice (MS) ili pridružene zemlje (AC), od kojih 2 ne mogu biti iz iste države.
- 7) **Konzorcijumski sporazumi** su obavezni.

2. da osiguraju optimalnu i usaglašenu upotrebu naprednih tehnologija za dobrobit sigurnosti evropskih građana.
3. da stimulišu saradnju krajnjih korisnika sa dobavljačima tehničkih rješenja za civilnu bezbjednost.
4. da unaprijede kompetitivnost evropske bezbjednosne industrije, i
5. da ponude dostupna rješenja u cilju smanjenja bezbjednosnih rizika.
